Dear Channa

I thank you for this email SINCERELY. Because at our first (and to date only) meeting, you came across as a genuine person I could trust about all things about my mother, like my step sister Rajakumari (Sukanya's mom). I hope you remember I commented that I would not have even fought this quardianship matter if it was I had met with you prior, and saved on the legal fees. I had shared this enthusiasm with my family and counted you in our team, that is why I sent you the live video link to monitor my mother (she always had 24X7 live monitoring from my family in India since becoming disabled) and the reports of her neglect at Paramount.

Therefore I was EXTREMELY confused and saddened with your subsequent emails and frosty attitude to me, and currently the bank fiasco and I was thinking something fishy was going on myself, to be honest. And frankly this email is weirdly comforting to me because it makes me believe again that you are genuinely on Omana's side so this is good news for us.

This email at the very least explains exactly where you are coming from, and from the limited misinformation you have garnered, I do not blame you as I can steer myself to misconstrue from your angle. This give me hope so I want to trust your judgment and go against my lawyer suggestion to keep my communication to you a minimum but I have nothing to hide so I want to be open.

So here are some facts:

- 1. My mother Omana is one of 10 children of a poor family of a Public Service Energy company's lineman for high voltage lines, named Pavros Kuttan Pillai who lived in Vanchiyoor, Thiruvananthapuram, Kerala, India. He also had four other wives besides my grandmom. All her mom's family lived in one room in socialist India (with no toilet) with their co-share of his wage of less than \$10 per month, yes month, so you can take out your calculator and compute the amount of ancestral wealth she inherited, and perhaps can go to Wall Street and hire another 10 more forensic accountants to do the same. (I apologize for the sarcasm). Mr. Kuttan Pillai died while in service, so by Indian laws the most educated adult among his children, i.e. Omana, got the job. - 2. In between she became a second wife to a lawyer Mr. G. Krishnan Nair (who had another wife from whom I have a half-brother who is a lawyer in India), and the couple's first son named Udayakrishnan became paralyzed at a tender age of three months due to an accident. His brain was traumatized and a blood clot formed in his medula oblangata section of his brain. So his growth was underdeveloped and needed full time care (ironically, much like Omana does now). Since my mom had a Govt job to go to, a precious thing in India, she adopted Rajakumari for help with taking care of my brother while also arranging for her education.
- 3. I was born much later, and when I was 12, my father passed away in 1993. In only three months, my brother also passed away because he was incessantly calling for my dad not being able to cope with his death and broke his heart (I was scared the same would happen to my mother if you did not let us meet in another day and she was burning up in fever with the same look on my brothers eyes when I met her).
- 4, My father's house and wealth (he was a lawyer and philanthropist after whom one of the major roads in the city of Thiruvananthapuram has been named) went to his first wife and my half brother. My mother and I got NOTHING from my fathers share after his death. She had me (who was in school) and Rajakumari and a job that paid what you would pay for Starbucks coffee in a month. I studied in government schools and colleges.

By virtue of standing in the top 0.002% of the candidates that appeared for Kerala State Public Entrance Exam, I got admitted to Government College of Engineering, where tuition is almost free and my mother could not have afforded a private college for me. But due to my merit I was able to get State assisted advanced education, and was able to apply for a patent at age 19 (attached). The Dean of the University also nominated for the top award of the nation awarded by the

President: the Indian National Potential Award 2000, and I also graduated with various other honors from my inventions (ironically, most of them were for paralyzed patients as I was motivated by my late brothers suffering I saw as a child and wanted to help paralyzed patients. I know right, a Hollywood writer could not have scripted this better!)

- 6. The honors, patent, top grades and the subsequent record GRE score (99 percentile) plus glowing recommendations (attached) got me the attention of a Prof at University of Massachusetts, named Prof. C. Mani Krishna. Although I had got an admission by virtue of outstanding merit, I tearfully wrote him that I will not be able to join because my mother cannot even afford my flight ticket, let alone my tuition. Therefore I declined the admit and joined the Hardware Research Wing of IBM Global Services in Bangalore, India.
- 7. Prof. Mani Krishna subsequently arranged a scholarship and Research Assistantship through his lab so I could join and collaborate on NASA projects. This was an offer too good to decline, so I left my mother (and a baby Sukanya) for the first time and flew to US to study MS in Computer Science at University of Massachusetts while EARNING more than average job after all tuition from my DARPA + NASA JPL research scholarship, which I also supplanted with teaching electronics to undergraduates as a teaching assistant. I was able to get a subsidized student housing apartment, so my mother was able to visit after the very first quarter I starter my graduate research and studies. THAT is how Omana got her first taste of coming to USA.
- 8. She had retired from KSEB in 1995, so she was able to visit me every six months and stay with me in the student quarters. She continued this rhythm of 6 months with me in the USA and 6 months in India with Rajakumari until 2014 when she had had the first stroke and could not return due to health reasons. We moved to Seattle in 2003 after I took up a job with Microsoft and she also joined me here. By age 27 I was managing a group of 26 engineers at Microsoft Next Generation Incident Management (NGIM) Group. I started investing in local real estate around 2005 and acquired three homes in Redmond (8646 230th Way NE Redmond, 6706 Quigley Ave SE Snogualmie and 13506 34th AVE SE Mill Creek.) by age 25 all financed from my Microsoft management job, and great credit.
- 9. In between, in 2007, while I was staying in 6706, my mother noticed that a neighborhood was being built next block for seniors that offered a discount for purchasers overs a certain age (I think it was 60) that she qualified for. She told me she would love to stay next doors to me and have me get married and raise a family at 6706 while she can take a walk to visit us everyday. She loved the new neighborhood backing to permanent greenbelt and the views and the floor plans.
- 10. Only problem was, she had no money, so I helped her out by transferring \$200,000 from my HELOC from 6706 Quigley with Countrywide Home Loans, to this very same joint account 3880 that you closed, back in 2007. Then a cashiers check was drawn in her name from this very same joint account for the purchase price and delivered to Escrow. We do not ever count our money as separate. I don't count how many eggs my moms eat and how many I eat out of a dozen. I wanted to make her happy and her dream come true, and being a SELF MADE MULTI MILLIONAIRE at age 27, I could AFFORD to do so.
- 11. She did not use one penny from her money from India to buy the home, it was a 100% GIFT from me to her. Nevertheless I was not lying it was her 35 years of hard work, because it was still her 35 years of hard work that bought the home for her and also reason I am here in the USA typing this email. If she did not do the hard yards, I would have had to drop out of school and ended in the streets of India as a slum dog not a millionaire (sorry could not resist the play on words). So I am obliged to her for everything she has done for us and she has been the quintessence of an ideal mother. She owns everything I have, and I come from a culture that says mata pita guru daivam (google it please). All she has is a paltry pension from her job as an accountant as I had mentioned earlier. But her two most biggest assets are her children that dedicate every penny we have for her.
- 12. My mom immediately moved into this home (6813 SE Gove St) after purchase, and as I was single at the time, I downgraded from the 6 bedroom I home she was living with me (6706 Quigley) next block to live in this cottage home. I put in \$40,000 worth of upgrades as this was now our family's primary home. I got married while living at this home. As my marriage gift and for reasons that she rather that I took care of everything for her (the depth of our bond is not something that can even be begun to be communicated in words), she transferred the home BACK to me so I can manage it along with the rest of the homes while she could enjoy a peaceful retired life.
- 13. In 2011 we moved to New Jersey, and although I had actually married a doctor to help take care of my mother's failing health, so she can have a medical expert at home at all times, the marriage did not work out and we returned to WA state in 2014. By this time my mother had had the first stroke and the heart surgery.
- 14. As mentioned in the other emails, I am working as an entrepreneur for a biotech startup, and our technologies are currently under FDA consideration. If you understand anything about how the biotech startup ventures operate, we license emerging promising technologies from world's leading schools, put it through FDA tests to get 510(k) or PMA certifications that can take a REALLY long time. Ours is currently in the dog study stage. During this incubation stage we have to bide time and provide lab date to FDA as we are not allowed to sell the products to humans without the FDA approvals so we have no income. Once we receive the approvals and patents (of which we already have several as you

can see from attached) we have a very high valuation and an exit plan in the hundreds of millions of dollars. In addition I am also working on a software startup.

- 15. In 2015 I was scammed by a lawyer Richard Symmes into filing a FALSE bankruptcy while I had nearly six million in total assets, and \$4.5 million in NET positive assets. This was presumably done to save me \$35,000 from a charged off debt (you can read the details from a separate email) but in reality what happened was he colluded with certain HOA lawyers to steal over \$300,000 in SCAM attorney fees from MY estate.
- 16. I filed a complaint against these thugs with King County Prosecutors Office. Details are Attached. I paid \$103K to trustee to release my REMAINING Net \$4.3 million assets back to me as you can see from attached Final Accounting.
- 17. In the last year I have been on a struggle my estate from these scammers. The HOA attorneys proceeded to file sheriff sales and my financial life was in turmoil from this and I was running pillar to post despite owning all these homes, real estate equity and biotech shares. Fortunately I have a text record of what was going on with her, and I want to trust you so I will request a private meeting at a starbucks between us so you can look at my phone and see for yourself all that is there to know about her.

My mother only has a pension in India that will not start to pay interest for the expenses I have borne for her over the years. To think I am living off of my mothers wealth, who is 100% my financial dependent, is laughable at best but at least I hope this clarifies.
