He forwarded a mail which he had sent you before...'Message from Omana'.. hope you have read it.Each and every word in that is correct..Let me make things clear..i have discussed things with my mom..You have said in the email that Jay has some intension in keeping mamma alive..first of all what i dont understand is that Mamma(Omana) doesn't have any wealth..and i have sent money to him and he gives me back..i asked him about the bank statements..he says that he has multiple accounts..I understand your situation and also my uncle's..i think there is a major misunderstanding between you both.. because I'm the only one hearing things from both the side..And things are more clear from Jay's side as I know him from childhood..and my mother also consider him as her son as there is a huge age difference between them.You might have done so many researches..but researches cannot be always true..I have heard so many things about Americans that after a particular age children go apart from their parents and does whatever they like without respecting there parents..But is that true? I don't think.. Hinduism has many beliefs and people follows that in many different ways..

Mamma lost two children and have suffered a lot and Jay is the last son..and they both are like one soul..i was so depressed to hear those words about my uncle from you..I couldn't speak a single word..I shouted at him out of depression by hearing all those things.. because what i heard from you was just opposite to what I have seen and what i know about him..Like you i also dont find any reason for holding mamma from death other than love..He has got nothing to do with her..The max amount i can give him or transfer him is Rs.5 or 6 lakhs..and you said that is nothing to him..even if she is alive or not..if Jay is in trouble we ll help him as much as we can..I'm helpless now..only i can travel to US and the Visa dates are on March 17th for biometric and april 15 to submit other documents..only after that i ll get Visa..Kindly do a favour to me and my family..we believe in Jay and you are mistaken..it is not his words important to our family..prime importance is to my mamma's life..This is 21st century and we women are not slaves of men... especially in my family..we have equal rights..We used to always video call them...i think you know that..and i dont know about criminals and drug addicts..i had frequent communication with the maids who were there before Mikky,Peggy and all..and i dont know from where the criminals came..He is the one who made arrangements to take mamma along with her..and he was treating her like a queen..My mom used to say that learn from him how a son taking care of his mom..and now i'm hearing from you just opposite to what i have heard from my mom..If this was the situation then why he left his job? Please i beg you..dont believe wrong things..

I went to visit with Omana yesterday and she was moaning and obviously uncomfortable. She kept reaching for my hand to hold my hand. While I was there she vomited, staff responded quickly and appropriately giving her a bath. Tonight I got a call that she continues to vomit, her oxygen level is low 92% and her heart rate is high. The concern is that when Jay was laying her bed flat she would throw up and it would get into her lungs. Omana needs to stay in a partially upright position at all times so she does not throw up. When Jay would crawl into bed with her he would lay her bed flat. This caused several episodes of vomiting. I received another call that she spiked a fever. I asked that they send her out to Harborview.

I really need you to talk with your mom. I have to determine whether or not we break your Grandmothers ribs in the event her heart stops. I don't know how familiar you are with her current physical status. She is in a lot of pain, because her brain tells her muscles to "tone" which means her muscles are always so tight that it causes contractures of her muscles. This is why she cannot straighten her legs anymore. She continues to have issues with infections. She had those at Jay's as well and had multiple hospitalizations. I need you and your mother, without the input of Jay because I feel like Jay has his own reasons why he wants to continue to put Omana through this. If Omana's heart were to stop, meaning she dies, naturally, Jay wants me to have the staff perform chest compressions which would break her ribs (regardless of Jay stating it would not, I've done this work a long time and I know it would). She would never recover from the horrific pain that would cause. Her heart may start beating again, but she would be so sedated from the pain medications that her heart would eventually stop.

I did a ton of research on Hinduism, your family has made it clear that God was important to Omana. In my research all I can find is that everything we are doing right now goes completely against her beliefs. Which concerns me greatly. Please correct me if I am wrong, being Hindu, life should not be prolonged artificially. We are doing that because we feed her through a feeding tube. If we performed CPR it would most definitely be artificially prolonging her life. Unless you feel that she has bad Karma that needs to be settled with this sort of suffering she should have been allowed to pass without this sort of suffering a long time ago. I want to honor Omana and I want the family to honor her. She was full of life before this stroke, I would not want this life for myself or my loved one. I would want them to move on to their next journey. So please, speak with your family, I know per Hinduism Jay has the final say, but that is no longer the case. I have the final say. His opinions are just his opinions. I worry that he has kept her in this condition for so long because it some how serves a purpose for him, whether he can get money from family claiming to be caring for her, or getting money from you to save "her" house because he did not pay the bills owed on the property. I don't know what his reasons are, but they are not based on what is in her best interest or what aligns with her faith. He has a lot of bad Karma, his losing these houses is probably because of how he kept his mother locked in one with people not trained to care for her while he went to play Poker in another State.

Please consider Omana, and her faith, and then advise me on what you want for her.
