Narrative

OFFICER: J.Fischbeck, #560 SMOQUALMIE POLICE DEPARTMENT CASE MUMPER: 188-1152 VICTIM / OFFENDER RELATIONSHIP: Mother (99 years of age) / Box (Caretaker) MARRATIVE:

On 03/13/2018 at about 1450 hours I received a report of a suspicious person at 5705 Quigley Ave SE, Enoqualmie. The reporter stated about 2 hours ego a female came to her door asking to berrow a blendar to crush up pills. The female was described a White, early 20's, dark bair, rad sweater with a white button down underseath, and black pants.

I conducted a check of the area shortly after receiving the call and did not see anything I would normally associate with narcotics activity nearby. I called the reporter, Marcie Obrien, who mentioned something was very strange with the young female. Marcie thought the female said something about an elderly woman in bed and she couldn't care for her. Reception was poor, so I told Marcie I would check the residence.

I arrived at the residence, 6706 Quiqly Ave SS, at about 1544 hours. As I approached the residence, Alexandra M Hall decided identified through her WA ID, dame out the front door. Rall immediately appeared relieved to see me and told we she was wondaring if the neighbors called her in. This confused me, as typically most people don't want to receive a visit from Police. Hall explained she was caring for an elderly woman by herself and didn't think she could do it anymore.

Hall invited me inside the residence. Inside I could see fresh groceries in the kitchem as if someone had just gone shopping. I could see many prescription bottles on the counter. On the kitchem counter was a list medications with some instructions. I could see several feeding tubes on the counter as well that appeared used. Hall showed me into a back room where I found Omans Thankkamma DOS 01/07/1919 (identified through prescription bottles) laying on a futon.

Omans didn't seem aware of my presence. Omans appeared old and freil. I could see a colostomy bag laying on the floor. Next to the bag appeared to be a stain from liquid food that hadn't yet been cleaned. Omans's bedding appeared fresh.

Hall relayed the following:

Hell has a history of DV and does not remember very well. Hell answored a Craigalist advertisement the previous week for a housekeeping position. Hell thought this meant cleaning dishes or assisting with household chores. Hell was offered 12-15\$ for 20 hours of work and the second 20 hours would go to room and board. Hell provided the Craigalist ad. Hell was a cook in a care facility prior, but other than that has no experience in home care or medical care. Hell is not licensed nor does she have any certication to dispense medications or preform basic medical procedures.

Hall winted several other females, Jenny and Ashley, were also hired to help care for Omana by Jayakrishnan K Nair DOS (identified by mail and business card, later by WA DL). Wair is Omana's son and primary caretaker / provider. Hall thought over the past 4 days she had been working non-stop, without breaks caring for Omana and cleaning the residence. Hall was given basic instructions on how to provide liquid food via feeding tube, medications, and change the colostomy bag for Omana by Ashley. Hall does not know what the medications are for or the side affects if not properly administered. When Hall

was showing me the redications she said "I am not familiar with all these". Hall said the other two caretakers left her alone to care for Omana. Hall didn't think she was qualified to care for Omana by berself.

During morning feeding (3/12/18), Hell was unable to provide the liquid breakfast to Omana. Hell was unable to feed Omana at all on 3/12/18.

Hall provided the text conversations between herself and Nair. I have added these to the case file. In the texts, it is clear Hall is in over her head and is requesting some type of CNA or EN to assist in the care.

Speaking with Hall, I do believe she has suffered from some sort of traumatic brain injury, whether from a DV incident or otherwise. Hall cannot focus on anything for more than a short while. Hall does not appear to understand consequences like a 26 year old should. Hall constantly asked me if I would excuse her from doing choras or otherwise Nair would be angry. Hall was very fearful Nair would be angry because I was there and she was not doing choras.

Hall pointed out the rooms all had numbers on them. The residence was also being used as an Air BnB as well as a care facility.

Sgt Graham arrived on scene and assisted. Snoqualsie Pire & Rescus was called and evaluated Omana. The decision was made to take Omana to Swedish Medical Center Issaquah for evaluation as she was non-verbal, hadn't been fed, we were unsure of which medication she was taking or had taken, and no one thought their was a qualified person to care for Omana in her emaciated state.

As we waited for transportation, I noticed the sheet of medications showed page 2 of 3. This means there was a page 1 and 3 of medications and instructions to go slong with the plethora of pill bottles that was not being followed as it was missing.

I called Nair and informed him of the situation. Nair stated he was en-route from Redmond. Nair immediately called Hall and I could hear yalling, I heard "what did I tell you about talking to the neighbors without my permission?!". At that point, I asked Hall for the phone and told Nair we would talk upon his arrival.

Omana was transported to Swedish Medical Center Issaquah without incident.

Nair and Ashley R Redican DOS (identified from her WA DL) arrived shortly after Omana was transported to the hospital. Nair was immediately defensive and asked if I knew who he was. Nair produced a business card problaiming himself to be a CEO of a bio-medical company. I explained to Nair that his position did not matter, I would investigate the possibility of neglect-regardless of position. Nair stated he is a good son who spends ten thousand dellars a month caring for his mother and providing the best care money could buy. Nair stated all his caretakers have experience in the medical field end that Ashley had her license.

Ashley relayed the following: she enswered a Craigalist ad about four days prior. Ashley told Mair her certification was not current, but her first aid, CPR, and food handlers parmits were. Ashley has 7+ years working in esisted living facilities (Ashley did not explain what this meant). Ashley had been assisting with home care and cleaning Mair's other properties. Ashley appears to have been cleaning properties and not caring for Cwans for most of the four days.

Ashley stated the third female caretaker was Jenny Galleges. I recognized this name as a local firm user, Jennifer M Galleges DEB Jennifer I showed Ashley a WA DOL and booking photo and thought that was the female. Ashley thought something was off with Jenny as she caught Jenny with old personal identification decomments of Nair's at one of the Redmond houses. Jenny left a few days prior and never returned.

Ashley and Hall provided written statements.

Som miller called Adult Propactive Services and informed them of our investigation. As it was after hours, a phone message and small was left with APS giving them our case number, and contact information. Further, they were cold that Omana was transported to Swedish in Issaguah, too.

I spoke with Swedish Medical Center Issaquah and explained the situation to the on-call social worker, the land murse, and ER doctor. Swedish Medical Center is going to keep Omana until ARS can essess the elemation. Swedish shared concerns about Omana's welfare and her imability to verbalize anything.

I checked Link, a law enforcement report aggregate system, for Nair. In January 2018, Nair was arrested for Asswilt 6th Degree on a caretaker. In 2016, KCSO did a welfare check listing the mother as Omana Ebankenna DOB Q2/23/1942. It is possible the listing on the prescription bottle is wrong. This new age would make Omana 77 years of age which makes new concerns about her health. At 98 years of age, Dmana's health made relative sense. At 75 years of age it makes last.

check of the Mashington State Department of Social and Saanu Japrices lists in home carergiver that is being paid as having to meet several requirement: pars a criminal background check, provide picture ID, not be the spouse of dared for subject, along a contract with WA DEMS, and successfully complete Caregiver raining requirements. The lowest level training (standard provider, category 1) raires 5 hours of prientation prior to providing care, and an additional 70 ra basic training in the next 100 ""ys. This is a state required

Hall am. Ashier both shated they sid not have current certifications to mare for, dispense medications, or insert feeding tubes / change colorions bags. Neither stated they completed the prerequisite 5 hours of orientation required.

Nair has assumed the responsibility to provide Comana the basic necessities of life. Nair racklessly abandoned Comana by finding inscartified and unqualified caretakers on Craigalist to dispense medications they have no idea what are for and perform basic medical procedures (feeding takes, collectomy bags) without my medical supervision. This created an immeriment and substantial risk that Comma would suffer substantial badly have if medications were improperly dispensed or not dispensed or if one of the medical procedures was done improperly (such as improped on 1/12, where Comana was not fed or given her prescribed pills). Omana improved to voice complaints or speak for heavelf if something is wrong or if the needs something. This duty should fall to qualified medical paraconnel trained to recognize when something is union.

At this time, I am not recommending charges for either Hall or Ashley due to Chair cooperation in this matter.

3/13/18 & Mair - Engressing Gratitude and Eleborating Pacts
E-mail concerning not compromising on care giving qualifications and experience.
The three homeospera are primarily hired for house work and not intensive dark
giving. Alexandra Hall and Jennifer Gallegos are housekeepers and not home care
workers. E-mail includes Hall's resume, food worker card, and references.

3/14/13 3-Mair - Ashley Redican 3-mail listing Ashley's previous certifications. It should be noted Ashley told responding officers has certification for home care was not our rent.

If an smill recommending Mair be charged with Abandonment of a Dependent Person. Neir last his aging mother who cannot care for herself in the care of unqualified and uncertified permons. These persons conducted medical procedures and dispensed medications to Omats without proper supervision, Gpon officer wist on V3/12, a complete list of medications and instructions was not located, only one page of three regarding medications was plainly visible near the pile of medications.
