- I was adopted when 3 months old by Jay's parents. Omana has been my mother all my life. We have a very close bond and speak to each other at least once a day.
- 2. I have been visiting my mother and brother in the USA since 2012, when Omana had a triple bypass surgery at Atlanticare Hospital in Pomona, NJ.
- 3. I have always found my mother to be happiest when she is with me and Jay, and she has shown the will to survive her medical issues only due to our love and devotion.
- 4. I am aware that Jay has done everything humanly possible, far beyond the call of duty for a son, to do his absolute best to care for Omana at his home as her Insurance denied her placement at a nearby skilled nursing facility as her condition required.
- 5. Jay quit his job to become her primary caregiver staying at home, and he also hired caregivers as well as housekeepers to the best of his affordability, and cared for her so well that she often remarked he was an ideal son and how blessed she is to have him.
- 6. After the fiasco with Snoqualmie Police taking her to the hospital from home, Omana was very upset and acutely over stressed about having to leave the home she loved.
- 7. Omana detested DSHS and their agents, and prayed to everyone to simply leave her alone so she can be happy and peaceful at home with her children for her last days.
- 8. Jay, Omana and I had discussed about a potential solution to ending the DSHS harassment with Omana being at a <u>Skilled Nursing Facility within 25 miles of his</u> <u>home with unrestricted visits</u>, and a quick path to her naturalization, which would shift the financial burden of her care from his shoulders, and would also allow him to resume his fulltime career. <u>Omana tearfully agreed ONLY for the sake of her son.</u>

- 9. However, we (her family in India) received several reports from our family and friends in USA, not just Jay, about her terrible condition and neglect and that instead of a Skilled Nursing facility, she had been "dumped" into a short-term shelter for the homeless by her new "guardian" Channa.
- 10. Omana found this place to be absolute hell and each day she would cry for hours pleading with Jay to take her home or for me to rescue her from there.
- 11. Her pictures, covered in dried vomit and excreta nearly 24x7 and without any lifesaving medications, let alone therapies, were gruesome and horrifying.
- 12. My daughter Sukanya tried to contact Channa to seek an alternative placement, but was told the utmost evil: that she did not believe Omana deserved to live in this condition, and that it would be better for everyone to let her die by withholding food and nutrition per her research on Hinduism. Channa is clueless about Omana.
- 13. We were petrified as we had just spoken to Omana for hours that same day and she had shared her dreams of seeing her family in India and wanting to live with Jay.
- 14. After Kavesh Sharma, Harirprasad, Jay and the rest of our family and friends informed us of her cruel murder and isolation, I flew to USA on June 12, 2019.
- 15. Before embarking I sent a detailed letter on May 31 from India on our mother's isolation and extrajudicial planned execution to several dignitaries including Hon. Foreign Minister of Indian Government Sri S, Jaishankar, Human Rights Watch director Arvind Ganesan, American Civil Liberties Union Seattle Chapter chairwoman Michelle Storms, US Senator For WA State Ms. Patty Murray, US Senator For WA State Ms. Maria Cantwell, CEO for Harborview Medical Center Dr. Paul Ramsey, WA State LTC Ombudsman Ms. Patricia Hunter, WA State DSHS

Secretary Ms. Cheryl Strange, WA State DSHS Sr. Director for Fraud &

Accountability Mr. Steve Lowe, and the Venerable Indian Consul General Sri. Sanjay Panda, among others, imploring for action to save her life [Attached as Exhibit A].

- 16. On June 13, after arriving in Seattle, I visited my mother at Paramount only to find that she was having a high fever, covered in dried vomit, delirious and unable to even recognize me. Her left hand had huge sacs of pulp from what looked like scalding.
- 17. I nearly fainted at her condition, then screamed and ran to the nursing station and asked for help. They were apathetic and did not seem to want to help.
- 18. They told me her temperature was normal and that her guardian did not want her to be taken to hospital, and asked me to pray for her soul and sit with her during her final moments. They said they had been instructed to do nothing but wait for her to die.
- 19. It was clear they were not giving her any life saving medication, and likely not even nutrition or water. The nursing assistant said the guardian thought it was burdensome for Omana to have to live in this condition and so to help her pass away peacefully.
- 20. I screamed in horror and called Jay. He spoke with his lawyer, and then I informed the staff that I would call 911 if they did not call for the paramedics, and it worked.
- 21. When the paramedics arrived, they checked her vitals and found her blood sugar was over 400, proving she never received any insulin or other life saving medication.
- 22. Her temperature was over 104 and she was running a high fever, but I had been told that she was not having a fever and "there was nothing to done for her any more".
- 23. Paramedics transported her to ER at Harborview. There she was treated at Burn ICU and the doctors mentioned it would be a miracle if she survived.
- 24. I filed complaints with DSHS, but their investigator Pam Rago was most apathetic.

- 25. She declined to take Omana's testimony or from Jay, and had one telephonic interview (I requested an interpreter as I am unfamiliar with American accent) with me in which the questions were more about deflecting the blame from DSHS and deliberately attempting at framing us than trying to find the bottom of this matter.
- 26. One such question from her co-investigator Nathan, was so vulgar (when I told him my mother's lips were noticed to be torn, he asked me "which set of lips") that the Malayalam interpreter on the phone refused to translate it and apologized to me on his behalf. Even the interpreter could not believe how nasty the questions were.
- 27. Convinced that Omana cannot get justice from DSHS, I also filed a police complaint on her attempted murder on July 3rd with Seattle Police Department.
- 28. On July 4th we left Omana's room around 10pm to watch Fireworks, and was greeted out of the room by her nurse Leah. We again met her on the 5th morning upon return.
- 29. Leah cordially let us inside the room. After about an hour a nurse Masumi came into the room and handed me a letter acknowledging receipt of my complaint, and left.
- 30. A few minutes later Dr. Andrew Hahn came into the room, and said that there was a report by Leah that something suspicious was found floating in her food previous night. We said we knew nothing about it, and asked him to investigate.
- 31. Jay left the room soon after Dr. Hahn left, so I can be with Omana until evening when he could come back to collect me. However, soon after he left, Masumi came into the room again with Harborview Security and placed me under false arrest.
- 32. I was asked to stay in a room near the lobby and to not move anywhere from there. I was very fearful. I waited in that room for nearly 5 hours under false arrest.
- 33. Jay came in the evening to collect me and was detained by security, who escorted

both of us out. We received a call from Dr. Hahn two days later saying that <u>he knew</u> we had nothing to do with this "foreign substance" story but that it would be in "our best interest" to not visit our mother for at least two weeks while he investigated.

- 34. He also divulged that wrong information had been given to detective Heather Barr about Omana having a serious infection (to cover-up her declining vitals at Paramount from deliberate neglect and lack of insulin), and that he had been asked to go on a vacation by Risk Management and to not respond to our emails.
- 35. The information from Dr. Hahn was the polar opposite to information that detective Heather Barr had received from Harborview Risk Management's cover-up plan.
- 36. Since July 5th, we have not had any information or response from Channa or Dr. Hahn or anyone at the hospital about our mother's whereabouts or condition. All our emails and calls are being ignored in name of "teaching us a lesson for complaining".
- 37. Although I am aware Omana's first preference would be to stay at her beloved home in Redmond with her son, if my mother is still alive, I am only glad to bring her back to India and take care of her at my home (as long as she can be safely transported in a medical flight) if, for any reason, her dying wish to spend her remaining limited time with her son at his home cannot be granted. Regardless however, her isolation and murder is prayed to be stopped and for her to be immediately returned to her children.

Respected Sri. Panda,

I am a senior staff member at the esteemed Mathrubhumi Newspaper, a leading National daily in India, urgently contacting you from Kerala, India, to report to you on behalf of all of my quadriplegic mother Ms. Omana Thankamma's family on her incredible plight and our mortal distress. Her life LITERALLY depends on your <u>immediate response</u>. She is currently in an absolute worst nightmare: being constantly sexually abused and severely neglected [Ex_AbusePictures] to die in solitary incarceration without any access to family or friends [Ex_HariEmail] at Paramount Nursing & Rehab center that your organization operates (if our understanding is correct) that also houses drug addicts and convicts for the short term. Her court-appointed guardian Ms. Channa Copeland is telling us she is helpless because Omana, as an "alien", has nowhere to go therefore no legal rights to live! She has also unilaterally changed her POLST code to NO RESUSCITATION [Ex_POLST] despite staunch opposition from all family members [Ex_EmailSukanya] and Omana's own humble mercy plea to her "guardian" by video to kindly let her live. Our agony at her pitiful situation is indescribable. WE ARE CONTACTING YOU TO URGENTLY MOVE HER TO SAFETY.

Our family in USA had observed and reported severe neglect and abuse at this shelter where nobody is available to come to her help for several hours, nor anyone can communicate with her due to her language barrier [Ex_AbusePictures]. On May 25th our visiting family members Kavesh Sharma [Ex_KaveshReport] and Jayakrishnan Nair [Ex_EmailChanna9] saw her unresponsive in a coma at the Paramount Homeless Shelter and had her taken to ER, and there were also unmistakable signs of sexual abuse such as broken lips on a locked-in, completely vulnerable (yet verbal) woman that still has no grey hair [Ex_AmmaPictures Pg #2], besides being ALWAYS drenched in her own excrements (as well as other helpless victims discarded there as may be seen anytime from a surprise investigation).

These terrifyingly unsettling & suspicious injuries and sex abuse reports from several of our family have also been independently confirmed by Dr. Sam Rackley at Harborview emergency room who treated her upon her most recent ER admission, who suspected she is a victim of sexual abuse from the presented wounds in her body. Despite these pictures and the repeated requests by family to move her to safety, her guardian Ms. Copeland ignores them.

To stop her from screaming in pain, she is being given Dantrolene Sodium [Ex_EmailChanna1] AGAINST all medical recommendation (her PCP had stopped a similar drug Baclofan after severe side effects and changed to Botox for alleviating her extreme cramps) at Shelter by resident Dr. Tran and that has caused severe reactions. Very recently Doctors at Harborview had to step in to make it stop finally. It makes her nauseated and passed out, and completely vulnerable to the mercy of dozens of convicts and drug addicts at this homeless shelter. She had been on a regimen of Botox pain injections every 6 months, and during her last visit on March 21 with her Neurologist Dr. Julie Hodapp, the injection could not be given only because Mr. Copeland was unavailable for a call from the physician's office to seek the Guardian's consent. <u>Omana has been denied MOST critical pain injections.</u>

My brother Jay was first trespassed in February from the facility by one Roger, an administrator at the Paramount Shelter citing a baseless HIPAA violation, for documenting the neglect as he found her unresponsive five times when visiting [Ex_EmailChanna1], and had her taken to ER at Harborview SEVERAL times where she has been treated for deadly infections and even suspected for ESBL (that has turned drug resistant) and MRSA that only spreads from open wounds at crowded prisons and extremely filthy nursing room environments. She medically needs a urinary catheter due to incontinence, and she had one at home for four years. However, paramount nursing does not have skilled nurses that knows to handle Urinary Catheter, and therefore they have forcibly removed the catheter AGAINST medical recommendation and put her on diapers, which are almost never changed leading her to quotidian recurring infections that have turned drug resistant. After he was readmitted through the efforts of his lawyers in visiting his mother, he was again trespassed on May 7 for questioning her sexual abuse by a perverted male black "nurse" named Tedlaw. He was held in illegal captivity for an hour and assaulted for trying to record the abuse, as witnessed by Paramount receptionist Peter and care aide Yohanon (may be spelt wrong).

The "guardian" seems completely uninterested in helping Ms. Omana, or the least bit bothered about her **MOST EXTREME** physical and mental pain from the cramps, sore eyes, isolation and sexual abuse, or knowledgeable about her emotional needs to spend time with family ([Ex_DrEdwardsReport] shows it is her only motivation to even live in her horrible and pitiable paralyzed state), and has continually and MOST diabolically refused to even hold ONE single initial meeting [Ex EmailChanna6, Ex EmailChanna10] so Omana can discuss directly through an interpreter to her guardian her concerns in the presence of somebody she trusts (like her long term speech therapist Dinesh Kannada or either one of her children), but Ms. Copeland refuses to listen to Omana's concerns even once. Furthermore, she is taking sides with paramount for restricting visits from family to obviate documentation of her inhuman neglect and abuse, (obviously for the reason of limiting her own liability from allowing the family to document her inhuman neglect and diabolic abuse while under her "guardianship") citing nonsensical reasons: such as a "report" from a "nurse" at Paramount that my brother was seen to give her chai tea by mouth (part of her daily routine for last 75 years - yes 75- and medically recommended for Dysarthria by two of her speech therapists in their care notes, which he had been doing for two years since her stroke [Ex_EmailDinesh]) that her son kissed her on cheeks?!! She has been cleared for aspiration risk from thin liquids following a MBS test after stroke, and has been enjoying her favorite chai with family every day. All details on her guardianship is on the ACLU complaint [Ex ACLU] submitted by my brother. She has been most cruelly abandoned by her grossly ineffective and self-serving "guardian" to die in solitude at Paramount (she cannot speak English and is now even devoid of her son's daily three hour visits, i.e. her only human interactions). Jay further reports that she took \$12,000 from his personal account that held money for his real estate business [Ex EmailChanna4] despite a thorough explanation of their finances [Ex EmailChanna5] and proof of personal sources [Ex wire] for 100% funds.

NOT A QUALIFYING PROGRAM FOR A PATIENT IN THANKAMMA'S TOTAL CARE CONDITION

1. Homeless* (see definition below):

Omana's family owns several homes in Redmond, Mill Creek and Snoqualmie (including a six bedroom mansion dedicated for her care [Ex_HomePictures]), in addition to over 35 AirBnB listings across multiple continents; so Omana is the perfect ANTONYM for homeless: yet being kept hostage against her will in a homeless shelter without even her medically required urinary catheter when she is MOST desperate to get back to her home that she calls her sanctuary. She is always 24x7 soaked in urine as Paramount does not have skilled nursing trained to use catheter (as we did at home for 4 years), and had 5 ER admissions for UTIs.

2. Acute medical problem requiring short-term respite care [4-6 weeks]

Omana is a medically stable quadriplegic that needs long term care and therapies three times a week from Speech Therapy, Occupational Therapy and Physical Therapy (including leg massages to prevent stiffening and cramps). All of those have been denied, and she is the only patient at Paramount who needs a PEG tube and an urinary catheter but the catheter has been removed leading to severe complications, repeating UTIs and deadly ESBL and MRSA infections requiring five Emergency Room admissions, all initiated by family after finding her unresponsive and completely covered in poop and vomit. Despite several warnings and pleas to the Guardian on not keeping her at the shelter, the Guardian has continued to do so (while also arrogantly telling our family, through our lawyer nonetheless, that she would not keep one of her DOGS at this filthy place for a day, and also that she wants our mother to die fast so she changed her POLST code.)

3. Medically and behaviorally stable (not a risk to self or others, appropriate for group setting)

My mother requires 24x7 TOTAL care and has needs like Catheter that Paramount is ill equipped to provide, and so she has suffered severe regressions from the time of her admission. Moreover she needs the constant emotional support and love from family and be able to communicate in her language Malayalam.

4. Independent in mobility, transfer, feeding, not known to be fall-risk at this time

Omana is completely immobile, requires feeding through a PEG tube in her stomach, and is kept 24x7 stationary in a bed without any physical MOVEMENT let alone exercises, or any mental stimulation (at home she used to watch Malayalam feed bunnies sitting in a wheelchair for hours) or even sitting up in a chair as medically needed for preventing muscular atrophy.

5. Agreeable to admission and receiving care from Respite staff

My mother has repeatedly told everyone she wants to go home, and documented her neglect and abuse at Paramount in her own words in several heartbreaking videos in Malayalam that we wish you to examine. [Ex_OmanaDeclaration]. She has a loving family of 5 adults and a luxury mansion with all facilities (and \$20,000 in upgrades made for her such as ramps, Hoyer lifts and power bed etc) that she has been living in for several years happily, peacefully, contentedly, attending cultural events & potllucks & birthday parties, and even leading Hindu Puja ceremonies and enjoying life as much as her body would allow, and cared & adored by loved ones at home [Ex_AmmaPictures], [Ex_HomePictures]. She spent 3-4 hours a day speaking with family in India in Malayalam.

Everything she loved, even sitting up in a chair and feeding bunnies in the serenity of our private fenced backyard, even a laptop, have been taken away from her. Our family's helpless frustration is only surpassed by her tribulation.

OMANA IS IN CRUCIFYING PAIN: BURNING EYES AND INTENSE LEG CRAMPS

1. Omana's right eye is burning up in pain from being denied a followup exam for her eye surgery in 7/18

Omana had cataract surgeries to both eyes, and the most recent one was on the right eye in July 2018 with Dr. Philip Chen that required a follow up appointments. The one to left eye already had one follow up visit in July and needed a second one. After the handing over to the guardian, she has not bothered to take her for any ONE SINGLE one of her LTC appointments, such as with her neurologist Dr. Hodapp, ophthalmologist Dr. Chen, or even PCP Dr. Diddee. Her only hospital appointments have been ER visits after family found her unresponsive, and all contact with her excellent care team that had been seeing her on average once a month have all been abruptly stopped. Omana's right eye has "kathunna vedhana", i.e "burning up" sensation from not getting the follow up treatment and she is therefore forced to keep them closed always even during waking hours. Family have pleaded the Guardian to take her AT THE VERY LEAST to her MOST CRITICAL followup visits or to Dr. Chen to see her eyes. However, the guardian tells us she has no insurance so she has no choice but to simply let her eyes burn. Apparently Omana only qualifies for emergency visits and not for long term care, so nearly ALL her Rehab of years is wasted.As can be seen from [Ex_AbusePics Pg#6], her right eye is developing nasty complications and losing vision. This needs to be urgently remedied and may need additional surgical procedures as Dr. Chen may be able to advise.

2. Omana's both legs are in unbearably harrowing pain from being denied regular Botox injections for pain

To alleviate the cramps and neuropathy from the stroke on her legs, at home we always used to keep her legs stretched with pillows in between (as you can seen from Ex_HomePictures and Ex_AmmaPictures). However, at the facility it is always left like in [AbusePics Page #6], which is the worst <u>TOTALLY AVOIDABLE</u> torture for her.

3. Omana's hitherto pristinely maintained Skin is literally torn up like a RAG DOLL. She is writhing with sores all over.

Please compare Dr. Nayak's report (before the beginning of this dreadful APS charade), with her skin condition from today after only few months at Paramount. The present condition of her skin is too painful to describe. She used to get almond oil massage and Vit-E lotion at home to keep her skin oily and obviate breaking.

4. Omana's legs are always held in cramped fetal position that is severely painful, despite many requests.

Her massage, physiotherapy AND Botox pain medications have ALL been abruptly discontinued, and she is not even getting her legs stretched and pillows in between to prevent the feet from collapsing into a fetal position that she is unable to prevent herself due to paralysis {[Ex_AbusePictures Pg#7 - please contrast with pgs #3 and #8 from [Ex_AmmaPictures]}. Therefore she keeps SCREAMING out in extremely brutal agony in Malayalam for someone to help her by stretching out her legs, but to no avail. To alleviate the screaming they make her go limp like wet noodles by giving her Dantrolene - a muscle relaxant that induces temporary paralysis ON TOP of her existing severe paralysis and making her unable to even raise her voice to cry in pain or to scream for help from predators.

5. Omana is being treated as a vegetable though she is a cogent individual with a language and slurring barrier

Omana had depression from stroke, but was making an excellent recovery from adjusting to her life after through the condition through strong emotional support and love from family. This has kept her going strong and there have been NO harm to her in any way from ANY lapse in care ever, and on the contrary she has thrived at home for over 2 years despite being discharged from St. Rose Dominican Hospital in NV after stroke with a low life expectancy. Our dedicated care and love has made her WANT to live and use her will to overcome adversity. But the evil being done to her and the physical pain has drained all her will to survive, and she is being treated like a vegetable though she is not, as she can still hold an intellectual conversation and do advanced arithmetic by mind.

<u>There is only one good word in English to describe the act of intentionally ending the life of a medically stable human</u> <u>being against their will, when they are not under a death warrant, or poses any threat to anyone: it is **MURDER**</u>

HUMBLE PRAYER FOR MOST URGENT AND EXPEDIENT ACTION

Mrs. Omana Thankamma's family is unanimously requesting the immediate action of your office to save Mrs. Thankamma from the ongoing murder at Paramount that she calls "Absolute Hell" in several videos where she has detailed her extreme abuse and neglect in her own words in Malayalam, which we are preparing in a CD to share with your office. if the attached petrifying pictures of abuse and neglect are not gruesome enough to arrest the criminal perpetrators Roger, Tedlaw, and Channa, Omana is also willing to state a personal testimony herself in Malayalam through an interpreter <u>IN THE PRESENCE OF HER FAMILY ONLY; as she distrusts and is scared of her "quardian" and will not speak for FEAR unless family is present</u>.

She has absolutely no legal, financial, moral or any other valid reason to be in the facility other than the pathetically farcical DSHS/APS charade based on an egregious police report of "abandonment" and the criminal intentions of Ms. Copeland to abuse the guardianship for nefarious purposes of purloining from her wealthy family that has a net worth of \$5 Million available for her care by using her access as ransom. She has already stolen \$12,000 though she knew from [Ex_EmailChanna5] and [Ex_Wire] that all of it was 100% my brother's personal money. She has also deliberately stalled on the Citizenship application [EmailChanna7].

After her most recent Emergency hospitalization, while my brother was visiting her with family on May 26, he was told by a member of nursing staff from Paramount (another black male - our mother is most extremely horrified at having her diapers changed almost exclusively by young black men), that he had been asked by Roger to keep an eye on our family (apparently he also worked shifts at Harborview that owns Paramount). From the fact that Mr. Roger has gone to the extent of spying on our family through his subordinates at other facilities, and looking for excuses to further block our family's access to Omana, Roger and Paramount administration's malicious desperation for covering up her barbaric abuse and neglect there from the public becomes quite obvious. By all accounts, this is a literal Auschwitz in the middle of Seattle.

This man reported [Ex_ERReport] to Charge nurse Ms. Sheila at ER that he had observed my brother giving Chai tea to our mother though it has been medically recommended to us to be continued by none other than the Speech Therapist at Paramount Ms. Yeketerina Vinokurova on 1/08/2019 after a recent evaluation, as can be seen from [Ex_STReport] that states: "Patient will improve swallow abilities as evidenced by ability to safely and efficiently swallow least restrictive diet (such as chai) with minimal to absent s/s oral dysphagia, coughing...swallows without aspiration". He also made another "allegation" that my brother "held pt's face and pt's son put lips on pt's cheeks" (i.e. in plain English, he <u>kissed his dying mom</u>). After her discharge from Harborview when family attempted to visit her at Paramount, Roger and Channa used these psychotic allegations (of son giving her Chai tea and kissing his mother on cheek) to block all access for ALL our family members and to hold her in complete isolation and illegal solitary confinement with no external contact or phone calls (her two phones, laptop, tea pot etc have been confiscated). Our anguish at this demonic evil to a paralyzed mother screaming for her kids in intolerable pain is beyond expressible.

In the light of these most exigent circumstances, I have already booked the tickets to be in Seattle this week and available in person as I will be staying in Redmond, USA (I usually come there for a month visit once every year to help my brother in taking care of our beloved mom who has been disabled since 2012, as can be seen from travel details in [Ex_RajiPassport]). I plan to take her back to our home from this hell that she has absolutely no reason whatsoever to be in but for a pathetic farce by the APS and Ms. Copeland's irresponsible negligence. Therefore, we are requesting to hold her at a qualified nursing facility (or a hospital like Harborview Medical Center) and to save her life until I reach there, although Ms. Copeland has kindly already agreed to release my mother from Paramount to our home ASAP once I reach there. 2.

She has also agreed to a video call on June 4th to prove to our family that Omana is still alive (though the facility will still not allow family physically go inside for fear of documenting her neglect by taking photos and videos of her abuse as attached, under the pretext of HIPAA violations and other nonsense). It is a highly mortal risk for Omana to be isolated from us and neglected without Botox at Paramount until my flight lands. Please call me at +91 77365 55608 (Kindly arrange a Malayalam interpreter) or please call my brother Jay who is local at (201) 205 7500. Both of us are available to meet this week to take Omana's testimony. She wants her children to be present so she can speak without fear to the investigators from your esteemed office. This disgusting, nauseating, evil farce has ben going on for far too far and I am embarking to USA to save her with your kind help. I am determined to be with her till the end, and if she fortunately outlives my six month stay at our home in Redmond, USA, for my upcoming trip [my USA visa and Indian passport details are attached in Ex_RajiPassport] I will take her back to my home in India.

HUMBLY PLEADING FOR URGENT ACTION to save our mother's life that is in most critical danger by moving her to a safe location and holding her with access to our family in USA (please note EX_VAPO does not have any restrictions on my brother other than restraining her from moving her back to home, therefore there is no legal reason or excuse to have violated our family's even fundamental human rights) until I am able to reach there; and to bring deserving justice to the abusers and the criminally negligent "guardian"; to allow Omana to give a TESTIMONY to the investigators from your office IN THE PRESENCE OF HER CHILDREN SO SHE CAN TALK WITHOUT FEAR.

1. PLEASE MOVE HER TO A PROPER CARE FACILITY (SUCH AS HARBORVIEW) IMMEDIATELY TO SAVE HER LIFE.

2. PLEASE HAVE HER TALK TO YOUR INVESTIGATORS IN OUR PRESENCE ASAP THROUGH AN INTERPRETER.

3. PLEASE HAVE HER ACCESS TO CARE & THERAPIES RESTORED, AS SHE HAD AT HOME BEFORE THIS FIASCO.

4. PLEASE HELP OMANA GET CITIZENSHIP & MEDICAID PER COURT ORDER [Ex GuardianshipSettlement]
